OPERATOR SAFETY TRAINING

POWERED INDUSTRIAL TRUCK OPERATOR TRAINING (CLASS 1/4/5)*

This course combines classroom and hands-on training. The training provides participants with an opportunity to learn the mandatory forklift requirements set forth by OSHA under the 29 CFR 1910.178 Standard. Additionally, this course discusses truck, task, and site-specific needs for PIT Class 1/4/5 Forklift operation and provides participants with important instruction on how to use their model-specific equipment in their work environment. Moreover, this training concludes with an end-of-course T/F test to measure mastery of knowledge. Facilities will receive training rosters, completed tests, and certificates of course completion upon payment. Each operator who successfully passes this course will receive a certificate that allows them to operate the PIT listed above with an expiration date of 3 years.

POWERED INDUSTRIAL TRUCK OPERATOR TRAINING (CLASS 2)*

This course combines classroom and hands-on training. The training provides participants with an opportunity to learn the mandatory forklift requirements set forth by OSHA under the 29 CFR 1910.178 Standard. Additionally, this course discusses truck, task, and site-specific needs for PIT Class 2 Forklift operation and provides participants with important instruction on how to use their model-specific equipment in their work environment. Moreover, this training concludes with an end-of-course T/F test to measure mastery of knowledge. Facilities will receive training rosters, completed tests, and certificates of course completion upon payment. Each operator who successfully passes this course will receive a certificate that allows them to operate the PIT listed above with an expiration date of 3 years.

POWERED INDUSTRIAL TRUCK OPERATOR TRAINING (CLASS 3)*

This course combines classroom and hands-on training. The training provides participants with an opportunity to learn the mandatory forklift requirements set forth by OSHA under the 29 CFR 1910.178 Standard. POWERED INDUSTRIAL TRUCK OPERATOR TRAINING (Container Handler Lift Truck)*

Facilities will receive training rosters, completed tests, and certificates of course completion upon payment. Each operator who successfully passes this course will receive a certificate that allows them to operate the PIT listed above with an expiration date of 3 years.

















OPERATOR SAFETY TRAINING

POWERED INDUSTRIAL TRUCK OPERATOR TRAINING (CLASS 7 Rough Terrain Forklift)*

This course combines classroom and hands-on training. The training provides participants with an opportunity to learn the mandatory forklift requirements set forth by OSHA under the 29 CFR 1910.178 Standard. Additionally, this course discusses truck, task, and site-specific needs for PIT Class 7 Forklift operation and provides participants with important instruction on how to use their model-specific equipment in their work environment. This training covers Telehandlers, Moffett's, Piggy Backs etc. Moreover, this training concludes with an end-of-course T/F test to measure mastery of knowledge. Facilities will receive training rosters, completed tests, and certificates of course completion upon payment. Each operator who successfully passes this course will receive a certificate that allows them to operate the PIT listed above with an expiration date of 3 years.

POWERED INDUSTRIAL TRUCK OPERATOR TRAINING (Combi-Lifts)*

This course combines classroom and hands-on training. The training provides participants with an opportunity to learn the mandatory forklift requirements set forth by OSHA under the 29 CFR 1910.178 Standard. Additionally, this course discusses truck, task, and site-specific needs for PIT Combi-Lift Forklift operation and provides participants with important instruction on how to use their model-specific equipment in their work environment. Moreover, this training concludes with an end-of-course T/F test to measure mastery of knowledge. Facilities will receive training rosters, completed tests, and certificates of course completion upon payment. Each operator who successfully passes this course will receive a certificate that allows them to operate the PIT listed above with an expiration date of 3 years.

TRAILER SPOTTER OPERATOR TRAINING

Operator Training for trailer spotters is a class that includes classroom and hands-on instruction. The classroom training consists of content generated from OSHA standards. The class, as a group, will complete the pre-shift inspection protocol in order to prepare for the evaluation. An end -of-course assessment will be administered, and a passing score is required to then complete the operator evaluation. Customers will receive training roster, completed tests, certificates of course completion, and participant evaluations upon payment.

Customers must ensure that the trailer spotter passes the manufacturer's pre-shift inspection. Additionally, participants must use air brakes (no single airline trailer hook-up) during training, operating, and evaluation. The class is taught exclusively on-site, using your organization's equipment. The Operator Manual must be provided in order to conduct class.

MOBILE ELEVATED WORK PLATFORM OPERATOR TRAINING

Mobile Elevated Work Platform Operator Training combines classroom instruction and hands-on that will include a discussion of ANSI regulations, as well as operator requirements for Type 1 Group A, Type 1 Group B, Type 3 Group A or Type 3 Group B work platforms. A multiple-choice test is administered after the classroom portion of training. The group will complete a pre-use inspection together prior to the assessment. A passing score is needed in order to complete the hands-on evaluation. The latter part of the class is dedicated to operator evaluations: pre-use inspection, operation, proper shutdown, etc. You will be given a copy of the training roster, completed tests, certifications of course completion, and participant evaluations upon payment.

NOTE: The new ANSI 92 standard has set forth new requirements for Dealers, Owners, Supervisors, Users, and Operators. Supervisors are required to comply with ANSI 92.24 section 7.5 training requirements. The classroom portion of this training meets the Supervisor requirement. Supervisors that do not become operator trained will recieve a seperate certificate stating they have been trained per the ANSI 92.24 Section 7.5 standard only.

















TRAIN THE TRAINER TRAINING

POWERED INDUSTRIAL TRUCK TRAIN THE TRAINER (Available for Class 1/2/3/4/5 Lift Trucks)

Train the Trainer is a class that assows our trainers to come to your location and educate your employees on the best practices of forklift usage. This is a one-day class that allows our instructors to provide a detailed overview of OSHA regulations, pre-shift inspection requirements, and the stability model. This training is classroom and hands-on. Our instructors will provide all presentation materials and notes to supplement the presentation documents to then enable your trainers to replicate the curriculum for new operators at your site. This class is preferably for experienced forklift operators who will then be responsible for teaching new operators in your place of business. Participants will conclude the class with a 50 question test, and an 90% pass rate corrected to 100% is required in order to receive a Train the Trainer certificate. Also, customers will receive training roster, completed tests, certificates of cours completion, and training materials upon payment. (Class is based upon your lift truck type and training needs.)

MOBILE ELEVATED WORK PLATFORM TRAIN THE TRAINER

Mobile Elevated Work Platform Train the Trainer Training is a full day class with classroom instruction that includes discussion of ANSI regulations, as well as equipment operation requirements. As in the MEWP Operator's Training, the group will complete a pre-use inspection together prior to the written assessment. A multiple-choice test is administered after the classroom portion of training. Facilities will receive training roster, completed tests, certificates of course completion, and all training materials upon successful completion of this course. The goal for this course is to prepare a qualified MEWP operator, to become a trainer, to then teach and qualify your employees to safely operate MEWP Equipment. This course is best suited for qualified operators.

Our MEWP Train the Trainer course at your facility will require your equipment to be available for presentation and hands-on training. The equipment should be in safe operating condition with current frequent and annual inspections. Please provide make and models at the time of registration.

TRAILER SPOTTER TRAIN THE TRAINER

Train the Trainer for Trailer Spotters is a one-day class that includes classroom instruction consisting of OSHA standards. The class, as a group, will complete the pre-shift inspection protocol. An end-of-course assessment will be administered to ensure comprehension of OSHA requirements and equipment handling. customers will receive training roster, completed tests, and certificates of course completion upon payment.

Customers must ensure that the trailer spotter passes the manufacturer's pre-shift inspection. Additionally, participants must use air brakes (no single airline trialer hook-up) during training, operating, and evaluation. The class is taught exclusively on -site, using your organization's equipment. The Operator Manual must be provided in order to conduct class.

POWERED INDUSTRIAL TRUCK TRAIN THE TRAINER (Container Handler - Big Trucks)

Train the Trainer is a class that allows our trainers to come to your location and educate your employees on the best practices of forklift usage. This is a one-day class that allows our instructors to provide a detailed overview of OSHA regulations, pre-shift inspection requirements, and the stability model. This training is classroom and hands-on. Our instructors will provide all presentation materials and notes to supplement the presentation documents to then enable your trainers to replicate the curriculum for new operators at your site. Course will cover how to properly inspect, wear and maintain your fall protection equipment; including Harnesses, Self-Retracting Lifelines and Lanyards. Fall Protection can be a standalone course or added to Operator Training. Your company/operator should supply harnesses for this training class.

FALL PROTECTION COMPETENT PERSON TRAINING

This training will be conducted at your site. Students need to provide their own harnesses for training. (Competent Person) - This two-day intermediate level course is designed for facility and site supervisors who must also serve as the competent person required by OSHA 1926.32(f), 1926.500 and 1910 standards. Participants are assigned tasks which require evaluation for fall hazards. The course also supplies the participant with the knowledge and skills to perform the annual inspection and record keeping. (Equipment Inspection) The Fall Protection Equipment Inspection training provides experience, methodology and in-depth look at all standards (ANSI & CSA) and regulations (OSHA) covering inspection of personal fall arrest systems. Additionally, a newly trained "competent person" who is responsible for the annual inspecting of personal fall arrest systems.
